II. DETAILED INFORMATION ABOUT THE FUNDING OPPORTUNITY

II.A. Program Description

Applications to the Fiscal Year 2020 (FY20) Melanoma Research Program (MRP) are being solicited for the Defense Health Agency (DHA) J9, Research and Development Directorate, by the U.S. Army Medical Research Acquisition Activity (USAMRAA) using delegated authority provided by United States Code, Title 10, Section 2358 (10 USC 2358). As directed by the Office of the Assistant Secretary of Defense for Health Affairs (OASD[HA]), the DHA manages the Defense Health Program (DHP) Research, Development, Test, and Evaluation (RDT&E) appropriation. The execution management agent for this Program Announcement is the Congressionally Directed Medical Research Programs (CDMRP). The MRP was initiated in 2019 to provide support for research of exceptional scientific merit in the field of melanoma. Appropriations for the MRP for FY19 totaled \$10 million (M). The FY20 appropriation is \$20M.

The proposed research must be relevant to active duty Service members, Veterans, military beneficiaries, and/or the American public.

The goal of the MRP is to prevent melanoma initiation and progression. The mission of the MRP is to support earlier intervention to enhance mission readiness for U.S. military personnel and to diminish the disease burden on Service members, Veterans, and the American public.

II.A.1. FY20 MRP Focus Areas

FY20 MRP Challenge Statement: The MRP challenges the research community to redefine the concept of prevention. Melanomagenesis is a multi-step process initiating from normal melanocytes to dysplasia, through the development of melanoma and metastasis. A new paradigm of prevention may include detection, monitoring, and stopping the initiation of dysplasia, halting the progress to malignancy, blocking micro-metastases, or preventing emergence from tumor dormancy. The MRP acknowledges that each step along the disease process from initiation to metastasis is an opportunity to detect, monitor, and impede progression and to effect a cure. The MRP challenges the research community to prevent melanoma earlier in the disease cycle, thus preventing metastasis. The melanoma clinical, research, and patient community traditionally view prevention as the use of sunscreen/blockers to protect the melanocyte from harmful ultraviolet (UV) radiation. The MRP recognizes the usefulness of this strategy while tasking the research community *to redefine prevention to include the entire melanomagenesis process*. The FY20 MRP Focus Areas promote the role of prevention throughout the disease process.

The MRP encourages studies for rare melanomas across the entire spectrum from initiation to distant macro-metastasis.

To be considered for funding, applications for the FY20 MRP Technology Development Partnership Award (TDPA) *must* address the following FY20 MRP Focus Area:

- Bioengineering (e.g., computational, imaging) approaches to address diagnostics, high risk markers, dormancy, and metastasis.

The MRP strongly encourages the use of Department of Defense (DoD)/Department of Veterans Affairs (VA) databases and participation by DoD/VA investigators.

II.B. Award Information

New for FY20: With the Technology Development Partnership Award (TDPA), the FY20 MRP encourages investigations into emerging technologies to assist in the detection, diagnosis, prognosis, and ultimately treatment of melanoma. The intent of the TDPA is to foster collaboration between biomedical sciences and physical sciences (e.g., bioengineering, computational science, imaging science, and bioinformatics) and spur progress in the development of computational approaches, bioinformatics, devices, or knowledge based products or outcomes, etc. A “Knowledge Product” is a non-materiel product that addresses an identified need in a melanoma, is based on current evidence and research, aims to transition into medical practice, training, tools, or to support materiel solutions (systems to develop, acquire, provide, and sustain medical solutions and capabilities), and educates or impacts behavior throughout the continuum of care, including primary prevention of negative outcomes.

The TDPA is a partnership award with an Initiating Principal Investigator (PI) and a Partnering PI. One PI must be from the biomedical sciences and one PI must be from the physical sciences. The TDPA encourages a cross-disciplinary approach to address research or patient outcome gaps in diagnostics, high risk markers, tumor dormancy, and tumor spread. It should be clear that the project will require both PIs and the project will benefit from each discipline’s perspective. Applications should apply a convergent methodology where a physical science approach lends support and enhancement to the understanding of melanoma initiation and progression. The project must clearly respond to the FY20 MRP Challenge Statement. The PI identified as the Initiating PI will be responsible for the majority of the administrative tasks associated with application submission. Both PIs should contribute significantly to the development of the proposed research project, including the Project Narrative, Statement of Work (SOW), and other required components. If recommended for funding, each PI will be named to an individual award within the recipient organization. For individual submission requirements for the Initiating and Partnering PI, refer to [Section II.D.2, Content and Form of the Application Submission](#). *The TDPA requires applicants to study one focus area within the melanoma field: bioengineering approaches to address diagnostics, high risk markers, dormancy, and metastasis.*

The critical components of this award mechanism are:

- **Impact:** The TDPA is intended to support research that demonstrates the potential to have a major impact on patient outcomes. The proposed study should demonstrate how the research will apply a convergent methodology where a physical science approach lends support and enhancement to the understanding of melanoma initiation and progression. Research should

respond to gaps in bioinformatics data management, computational analysis, imaging development, or other relevant technological needs in the melanoma field with a clear target to impact research and/or patient outcomes. Impactful research will, if successful, accelerate the movement of promising ideas into clinical applications and advance the evaluation and understanding of melanoma diagnostics, high risk markers, dormancy, and progression to metastasis.

- **Preliminary Data:** The TDPA is intended to support cross-disciplinary investigations that advance the melanoma research field forward by utilizing previous research findings. *Applications must include preliminary data to support feasibility of the study.* Any unpublished, preliminary data provided should originate from the laboratory of the PIs or a member(s) of the research team.
- **Cross-Disciplinary Personnel and Collaboration:** The success of the project depends on the unique skills and contributions of each collaborator. One PI must be from the biomedical field and one PI must be from a physical science field. Each PI should have an intellectual stake in the project and offer the necessary skillsets and expertise to successfully complete the research. The PIs should demonstrate a collaboration plan. If the PIs are at different institutes, then a plan to deal with intellectual property and material transfer should be included. It is encouraged to have one military, VA collaborator, or early career investigator.
- **Technological Design:** The technological design of the research should integrate tenets from a biomedical field with a physical science field. Techniques ranging from field such as quantitative science, mathematics, computer science, or engineering, may be merged with biomedical sciences to answer a specific need in the study of melanoma (diagnostics, high risk markers, dormancy, and metastasis). Technological study design may include demonstration of requirement analysis, architecture design, technical/derived technical requirements, verification and validation analysis, methodology, and technical planning, etc.

With the exception of those studies investigating rare melanomas, the FY20 MRP is not requesting research into established macrometastatic disease, models of metastatic disease using established cell lines, or treatment of macrometastatic disease. The MRP encourages studies for rare melanomas across the entire spectrum from initiation to distant macro-metastasis.

Studies involving non-melanoma skin cancers are not allowed under the FY20 MRP.

A Congressionally mandated Metastatic Cancer Task Force was formed with the purpose of identifying ways to help accelerate clinical and translational research aimed at extending the lives of advanced state and recurrent patients. As a member of the Metastatic Cancer Task Force, CDMRP encourages applicants to review the recommendations (<https://health.mil/Reference-Center/Congressional-Testimonies/2018/05/03/Metastatic-Cancer-Research>) and submit research ideas to address these recommendations, provided they are within the limitations of this funding opportunity and fit within the FY20 MRP priorities.

The types of awards made under the Program Announcement will be assistance agreements. An assistance agreement is appropriate when the Federal Government transfers a “thing of value” to

a “state, local government,” or “other recipient” to carry out a public purpose of support or stimulation authorized by a law of the United States instead of acquiring property or service for the direct benefit and use of the U.S. Government. An assistance agreement can take the form of a grant or cooperative agreement. The level of involvement on the part of the DoD during project performance is the key factor in determining whether to award a grant or cooperative agreement. If “no substantial involvement” on the part of the funding agency is anticipated, a grant award will be made (31 USC 6304). Conversely, if substantial involvement on the part of the funding agency is anticipated, a cooperative agreement will be made (31 USC 6305), and the award will identify the specific substantial involvement. Substantial involvement may include, but is not limited to, collaboration, participation, or intervention in the research to be performed under the award. The award type, along with the start date, will be determined during the negotiation process.

The anticipated direct costs budgeted for the entire period of performance for an FY20 MRP TDPA award will not exceed **\$700,000**. Refer to [Section II.D.5, Funding Restrictions](#), for detailed funding information.

Awards will be made no later than September 30, 2021. For additional information refer to [Section II.F.1, Federal Award Notices](#).

The CDMRP expects to allot approximately \$2.24M to fund approximately two (2) Technology Development Partnership Award applications. Funding of applications received is contingent upon the availability of Federal funds for this program as well as the number of applications received, the quality and merit of the applications as evaluated by scientific and programmatic review, and the requirements of the Government. Funds to be obligated on any award resulting from this funding opportunity will be available for use for a limited time period based on the fiscal year of the funds. It is anticipated that awards made from this FY20 funding opportunity will be funded with FY20 funds, which will expire for use on September 30, 2026.

Research Involving Human Anatomical Substances, Human Subjects, or Human Cadavers: All DoD-funded research involving new and ongoing research with human anatomical substances, human subjects, or human cadavers must be reviewed and approved by the U.S. Army Medical Research and Development Command (USAMRDC) Office of Research Protections (ORP), Human Research Protection Office (HRPO), prior to research implementation. This administrative review requirement is in addition to the local Institutional Review Board (IRB) or Ethics Committee (EC) review. Local IRB/EC approval at the time of submission is *not* required. ***Allow a minimum of 2 to 3 months for HRPO regulatory review and approval processes.*** Refer to the General Application Instructions, Appendix 1, and the Human Subject Resource Document available on the electronic Biomedical Research Application Portal (eBRAP) “Funding Opportunities & Forms” web page (<https://ebrap.org/eBRAP/public/Program.htm>) for additional information. If the proposed research is cooperative (i.e., involving more than one institution), a written plan for single IRB review arrangements must be provided at the time of application submission or award negotiation. The lead institution responsible for developing the master protocol and master consent form should be identified and should be the single point of contact for regulatory submissions and requirements.

Clinical trials are not allowed.

A clinical trial is defined as a research study in which one or more human subjects are prospectively assigned to one or more interventions (which may include placebo or other control) to evaluate the effects of the interventions on biomedical or behavioral health-related outcomes.

Use of DoD or VA Resources: If the proposed research involves access to active duty military patient populations and/or DoD resources or databases, the application must describe the access at the time of submission and include a plan for maintaining access as needed throughout the proposed research. Refer to [Section II.D.2.b.ii, Full Application Submission Components](#), for detailed information. Refer to the General Application Instructions, Appendix 1, for additional information.

Research Involving Animals: All DoD-funded research involving new and ongoing research with animals must be reviewed and approved by the USAMRDC ORP Animal Care and Use Review Office (ACURO), in addition to the local Institutional Animal Care and Use Committee (IACUC) of record. IACUC approval at the time of submission is *not* required. *Allow at least 3 to 4 months for ACURO regulatory review and approval processes for animal studies.* Refer to the General Application Instructions, Appendix 1, for additional information.

II.C. Eligibility Information

II.C.1. Eligible Applicants

II.C.1.a. Organization: All organizations, including international organizations, are eligible to apply.

Government Agencies Within the United States: Local, state, and Federal Government agencies are eligible to the extent that applications do not overlap with their fully funded internal programs. Such agencies are required to explain how their applications do not overlap with their internal programs.

As applications for this Program Announcement may be submitted by extramural and intramural organizations, these terms are defined below.

Extramural Organization: An eligible non-DoD organization. Examples of extramural organizations include academic institutions, biotechnology companies, foundations, Federal Government organization other than the DoD, and research institutes.

Intramural DoD Organization: A DoD laboratory, DoD military treatment facility, and/or DoD activity embedded within a civilian medical center. *Intramural Submission: Application submitted by a DoD organization for an intramural investigator working within a DoD laboratory or military treatment facility or in a DoD activity embedded within a civilian medical center.*

USAMRAA makes awards to eligible organizations, not to individuals.

II.C.1.b. Principal Investigator

To be named as a PI on the application, the investigators (Initiating PI and Partnering PI) must have a faculty level appointment or equivalent.

An eligible PI, regardless of ethnicity, nationality, or citizenship status, must be employed by, or affiliated with, an eligible organization.

The CDMRP encourages all PIs to participate in a digital identifier initiative through Open Researcher and Contributor ID, Inc. (ORCID). Registration for a unique ORCID identifier can be done online at <https://orcid.org/>.

II.C.2. Cost Sharing

Cost sharing/matching is not an eligibility requirement.

II.C.3. Other

Organizations must be able to access **.gov** and **.mil** websites in order to fulfill the financial and technical deliverable requirements of the award and submit invoices for payment.

For general information on required qualifications for award recipients, refer to the General Application Instructions, Appendix 3.

Refer to [Section II.H.2, Administrative Actions](#), for a list of administrative actions that may be taken if a pre-application or application does not meet the administrative, eligibility, or ethical requirements defined in this Program Announcement.

II.D. Application and Submission Information

Submission of applications that are essentially identical or propose essentially the same research project to different funding opportunities within the same program and fiscal year is prohibited and will result in administrative withdrawal of the duplicative application(s).

Extramural Submission:

- Pre-application content and forms must be accessed and submitted at eBRAP.org.
- Full application packages must be accessed and submitted at Grants.gov.

Intramural DoD Submission:

- Pre-application content and forms must be accessed and submitted at eBRAP.org.
- Full application packages must be accessed and submitted at eBRAP.org

Note: Applications from an intramural DoD organization or from an extramural Federal Government organization may be submitted to Grants.gov through a research foundation.

II.D.1. Address to Request Application Package

eBRAP is a multifunctional web-based system that allows PIs to submit their pre-applications electronically through a secure connection, to view and edit the content of their pre-applications and full applications, to receive communications from the CDMRP, and to submit documentation during award negotiations and period of performance.

Contact information for the CDMRP Help Desk and the Grants.gov Contact Center can be found in [Section II.G, Federal Awarding Agency Contacts](#).

II.D.2. Content and Form of the Application Submission

Submission is a two-step process requiring both *pre-application* (eBRAP.org) and *full application* (eBRAP.org or Grants.gov) as indicated below. The submission process should be started early to avoid missing deadlines. There are no grace periods. Full application submission guidelines differ for extramural (Grants.gov) and intramural (eBRAP.org) organizations (refer to [Table 1. Full Application Guidelines](#)).

The application title, eBRAP log number, and all information for the PI, Business Official(s), performing organization, and contracting organization must be consistent throughout the entire pre-application and full application submission process. Inconsistencies may delay application processing and limit or negate the ability to view, modify, and verify the application in eBRAP. If any changes need to be made, the applicant should contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507 prior to the application submission deadline.

The Initiating PI must complete the pre-application submission process and submit the contact information for the Partnering PI. The Partnering PI will then be notified of the pre-application submission separately by email. ***The Partnering PI must follow the link in the notification email in order to associate their full application package with that of the Initiating PI. After following the link, the Partnering PI must verify their contact information, organization, and designation as an extramural or intramural submission within eBRAP.*** If not previously registered, the Partnering PI must register in eBRAP. A new pre-application based on this research project should not be initiated by the Partnering PI. Applicants are urged to complete these steps as soon as possible. If they are not completed, the Partnering PI will not be able to view and modify their application during the verification period in eBRAP. If these steps are not completed, an intramural partner will not be able to submit the Partnering PI's required full application package components to eBRAP.

II.D.2.a. Step 1: Pre-Application Submission Content

During the pre-application process, eBRAP assigns each submission a unique log number. This unique eBRAP log number is required during the full application submission process.

To begin the pre-application process, first select whether the submitting organization is extramural or intramural, then confirm your selection or cancel. **Incorrect selection of extramural or intramural submission type will delay processing.**

If an error has been made in the selection of extramural versus intramural and the pre-application submission deadline has passed, the PI or Business Official must contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507 to request a change in designation.

All pre-application components must be submitted by the Initiating PI through eBRAP (<https://eBRAP.org>). Because the invitation to submit an application is based on the contents of the pre-application, investigators should not change the title or research objectives after the pre-application is submitted.

The applicant organization(s) and associated PIs identified in the pre-application should be the same as those intended for the subsequent application submission. If any changes are necessary after submission of the pre-application, the applicant must contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507.

A change in PI or organization after submission of the pre-application may be allowed after review of a submitted written appeal (contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507) and at the discretion of the USAMRAA Grants Officer.

PIs with an ORCID identifier should enter that information in the appropriate field in the “My Profile” tab in the “Account Information” section of eBRAP.

The pre-application consists of the following components, which are organized in eBRAP by separate tabs (refer to the General Application Instructions, Section II.B, for additional information on pre-application submission):

- **Tab 1 – Application Information**

Submission of application information includes assignment of primary and secondary research classification codes, which may be found at <https://eBRAP.org/eBRAP/public/Program.htm>. Applicants are strongly encouraged to review and confirm the codes prior to making their selection.

- **Tab 2 – Application Contacts**

Enter contact information for the PI. Enter the organization’s Business Official responsible for sponsored program administration (the “person to be contacted on matters involving this application” in Block 5 of the Grants.gov SF424 Research & Related Form). The Business Official must be either selected from the eBRAP list or invited in order for the pre-application to be submitted.

Select the performing organization (site at which the PI will perform the proposed work) and the contracting organization (organization submitting on behalf of the PI, which corresponds to Block 5 on the Grants.gov SF424 Research & Related Form), and click on “Add Organizations to this Pre-application.” The organization(s) must be either selected from the eBRAP drop-down list or invited in order for the pre-application to be submitted.

It is recommended that PIs identify an Alternate Submitter in the event that assistance with pre-application submission is needed.

- **Tab 3 – Collaborators and Key Personnel**

Enter the name, organization, and role of all collaborators and key personnel associated with the application.

[FY20 MRP Programmatic Panel members](#) should not be involved in any pre-application or application. For questions related to panel members and pre-applications or applications, refer to [Section II.H.2.c, Withdrawal](#), or contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507.

The Initiating PI must enter the contact information for the Partnering PI in the Partnering PI section.

- **Tab 4 – Conflicts of Interest**

List all individuals other than collaborators and key personnel who may have a conflict of interest in the review of the application (including those with whom the PI has a personal or professional relationship).

- **Tab 5 – Pre-Application Files**

Note: Upload documents as individual PDF files unless otherwise noted. eBRAP will not allow a file to be uploaded if the number of pages exceeds the limit specified below.

- **Preproposal Narrative (two-page limit):** The Preproposal Narrative page limit applies to text and non-text elements (e.g., figures, tables, graphs, photographs, diagrams, chemical structures, drawings) used to describe the project. Inclusion of URLs that provide additional information to expand the Preproposal Narrative and could confer an unfair competitive advantage is prohibited and may result in administrative withdrawal of the pre-application.

The Preproposal Narrative should include the following:

- Explain how the proposed research will lead to promising outcomes for the FY20 MRP Focus Area: Bioengineering (e.g., computational, imaging) approaches to address diagnostics, high risk markers, dormancy, and metastasis. State how the proposed research is responsive to the FY20 MRP Challenge Statement.
- State the area of physical science to be studied. Include the biomedical focus of the study such as diagnostics, high risk markers, dormancy, and metastasis.
- Identify the areas of expertise of the Initiating PI and the Partnering PI. Describe how the success of the project depends on the unique skills and contributions of each PI.
- Show how the project uses cross-disciplinary approaches to address research or patient outcome gaps in diagnostics, high risk markers, tumor dormancy, and/or tumor spread.

- State the project’s hypothesis, objectives, rationale, and specific aims. Describe the technological study design, rationale, and methodology to test the hypothesis and the specific aims of the project. Demonstrate how the research is based on strong preliminary data.
- Briefly describe the impact the research will have, if successful, on patient care and/or outcomes.
- **Pre-Application Supporting Documentation:** The items to be included as supporting documentation for the pre-application *must be uploaded as individual files* and are limited to the following:
 - References Cited (one-page limit): List the references cited (including URLs if available) in the Preproposal Narrative using a standard reference format that includes the full citation (i.e., author[s], year published, reference title, and reference source, including volume, chapter, page numbers, and publisher, as appropriate).
 - List of Abbreviations, Acronyms, and Symbols: Provide a list of abbreviations, acronyms, and symbols used in the Preproposal Narrative.
 - Key Personnel Biographical Sketches (five-page limit per individual). *All biographical sketches should be uploaded as a single combined file.* Biographical sketches should be used to demonstrate background and expertise through education, positions, publications, and previous work accomplished.

- **Tab 6 – Submit Pre-Application**

This tab must be completed for the pre-application to be accepted and processed.

Pre-Application Screening

- **Pre-Application Screening Criteria**

To determine the technical merits of the pre-application and the relevance to the mission of the DHP and the MRP, pre-applications will be screened based on the following criteria:

- Whether the proposed project addresses at the FY20 MRP Focus Area: Bioengineering (e.g., computational, imaging) approaches to address diagnostics, high risk markers, dormancy, and metastasis. Whether the proposed project addresses the FY20 MRP Challenge Statement.
- Whether the pre-application states the area of physical science to be studied. Whether the pre-application includes the biomedical focus of the study such as diagnostics, high risk markers, dormancy, and metastasis.
- Whether the pre-application identifies the areas of expertise of the Initiating PI and the Partnering PI. To what extent the success of the project depends on the unique skills and contributions of each PI.

- To what degree the pre-application demonstrates the project’s cross-disciplinary approach addresses research or patient outcome gaps in diagnostics, high risk markers, tumor dormancy, and/or tumor spread.
 - Whether the pre-application states the project’s hypothesis, objectives, rationale, and specific aims. How well the technological study design, rationale, and methodology will evaluate the hypothesis and the specific aims of the project. Whether the preliminary data supports the research proposed.
 - Whether the research, if successful, will have the impact on patient care and/or outcomes.
- **Notification of Pre-Application Screening Results**

Following the pre-application screening, Initiating PIs will be notified as to whether or not they are invited to submit applications; however, they will not receive feedback (e.g., a critique of strengths and weaknesses) on their pre-application. The estimated timeframe for notification of invitation to submit an application is indicated in [Section I, Overview of the Funding Opportunity](#). Invitations to submit a full application are based on the Pre-Application Screening Criteria listed above.

II.D.2.b. Step 2: Full Application Submission Content

Applications will not be accepted unless notification of invitation has been received by the Initiating PI.

The CDMRP cannot make allowances/exceptions to its policies for submission problems encountered by the applicant organization using system-to-system interfaces with Grants.gov.

Each application submission must include the completed full application package for this Program Announcement. The full application package is submitted by the Authorized Organizational Representative through Grants.gov (<https://www.grants.gov/>) for extramural organizations or through eBRAP (<https://ebrap.org/>) for intramural organizations. See Table 1 below for more specific guidelines.

II.D.2.b.i. Full Application Guidelines

Extramural organizations must submit full applications through Grants.gov. Applicants must create a Grants.gov Workspace for submission, which allows the application components to be completed online and routed through the applicant organization for review prior to submission. Applicants may choose to download and save individual PDF forms rather than filling out webforms in Workspace. A compatible version of Adobe Reader **must** be used to view, complete, and submit an application package consisting of PDF forms. If more than one person is entering text into an application package, the **same version** of Adobe Reader software should be used by each person. Check the version number of the Adobe software on each user’s computer to make sure the versions match. Using different versions of Adobe Reader may cause submission and/or save errors – even if each version is individually compatible with Grants.gov. Refer to the General Application Instructions, Section III, and the “Apply For Grants” page of Grants.gov (<https://www.grants.gov/web/grants/applicants/apply-for-grants.html>) for further

In addition, there are file size limits that may apply in some circumstances. Individual attachments may not exceed 20 MB, and the file size for the entire full application package may not exceed 200 MB. *It is important to include the attachment name as a header on each page of the attachment files.*

- **Attachment 1: Project Narrative (12-page limit): Upload as “ProjectNarrative.pdf”.** The page limit of the Project Narrative applies to text and non-text elements (e.g., figures, tables, graphs, photographs, diagrams, chemical structures, drawings) used to describe the project. Inclusion of URLs that provide additional information to expand the Project Narrative and could confer an unfair competitive advantage is prohibited and may result in administrative withdrawal of the application.

Describe the proposed project in detail using the outline below. *Inclusion of preliminary data is required.*

- **Background:** Describe the gap within the melanoma field (e.g., diagnostics, high risk markers, dormancy, and metastasis) to be addressed. Articulate the rationale for the study in terms of the gap and how response to the gap will improve clinical care or patient outcomes.
- **Hypothesis and Objective:** State the hypothesis to be tested and the objective to be reached within the FY20 MRP Focus Area: Bioengineering approaches to address diagnostics, high risk markers, dormancy, and metastasis. State how the proposed project addresses the FY20 MRP Challenge Statement.
- **Specific Aims:** State the specific aims of the study
- **Research Strategy and Feasibility:** Describe the rationale to test the hypothesis and reach the final objective. Include preliminary data and reconcile it with objectives of the research proposed. Preliminary data such as published or unpublished results from the laboratory and/or clinic of the PI or collaborators named on this application must be included. Describe the technological study design to potentially include demonstration of requirement analysis, architecture design, technical/derived technical requirements, verification and validation analysis, methodology, and technical planning, etc. Describe the statistical evaluation and validation of the technology, especially the specificity and selectivity. Describe potential problems and potential pitfalls, and address alternative approaches. Demonstrate the availability of tissue, data, or human subjects, if applicable. Research projects may include preclinical studies in animal models or clinical research involving human subjects and human anatomical substances. If human subjects or human anatomical samples will be used, include a plan for the recruitment of subjects or the acquisition of samples, and document the experience of the PI and/or key collaborators in recruiting human subjects for similar projects. Describe all animal studies, how the animal model recapitulates melanoma, and how the studies are designed to achieve the objectives, including endpoints/outcome measures to be used, if applicable.
- **Attachment 2: Supporting Documentation: Combine and upload as a single file named “Support.pdf”.** Start each document on a new page. - Facilities, Existing Equipment, and Other Resources: Describe the facilities and equipment available for performance of the proposed project and any additional facilities or equipment proposed for acquisition at no cost to the award. Indicate whether or not Government-furnished facilities or equipment are proposed for use. If so, reference should be made to the original or present Government award under which the facilities or equipment items are now accountable. There is no form for this information.
- Publications and/or Patents: Include a list of relevant publication URLs and/or patent abstracts. If articles are not publicly available, then copies of up to five published manuscripts may be included in Attachment 2. Extra items will not be reviewed.

 - **Impact:** Briefly describe how research demonstrates the potential to have a major impact on patient outcomes. Describe how, if the research is successful, it will accelerate the movement of promising ideas into clinical applications and advance the evaluation and understanding of melanoma diagnostics, high risk markers, dormancy, and tumor spread (progression to metastasis).
 - **Specific Aims:** State the specific aims of the study.
 - **Study Design:** Briefly describe how the proposed research will apply a convergent methodology where a physical science approach lends support and enhancement to understanding of melanoma initiation and progression. Articulate how the research

- responds to gaps in bioinformatics data management, computational analysis, imaging development, or other relevant technological needs in the melanoma field.
- **Attachment 4: Lay Abstract (one-page limit): Upload as “LayAbs.pdf”.** The lay abstract is used by all reviewers. Abstracts of all funded research projects will be posted publicly. **Do not include proprietary or confidential information.** Use only characters available on a standard QWERTY keyboard. Spell out all Greek letters, other non-English letters, and symbols. Graphics are not allowed.

Lay abstracts should be written using the outline below. Do not duplicate the technical abstract. Avoid overuse of acronyms and abbreviations, if possible. Describe the proposed research project by including the following elements in plain language.

- State the gap within the melanoma field (e.g., diagnostics, high risk markers, dormancy, and metastasis) to be addressed.
 - Describe the scientific objective and rationale for the proposed project in a manner that will be readily understood by readers without a background in science or medicine.
 - In lay persons’ terms described how the proposed research has the potential to have a major impact on patient outcomes. Describe how, if the research is successful, it will accelerate the movement of promising ideas into clinical applications and advance the evaluation and understanding of melanoma diagnostics, high risk markers, dormancy, and tumor spread (progression to metastasis).
- **Attachment 5: Statement of Work (three-page limit): Upload as “SOW.pdf”.** The suggested SOW format and examples specific to different types of research projects are available on the eBRAP “Funding Opportunities & Forms” web page (<https://ebrap.org/eBRAP/public/Program.htm>). For the Technology Development Partnership Award mechanism, use the SOW format example titled, “SOW (Statement of Work) Generic Format.” The SOW must be in PDF format prior to attaching.

The SOW should include a list of major tasks that support the proposed specific aims, followed by a series of subtasks outlined related to the major tasks and milestones within the period of performance. The SOW should describe only the work for which funding is being requested by this application and, as applicable, should also:

Each PI must submit an identical copy of a jointly created SOW. The contributions of the Initiating PI and the Partnering PI should be noted for each task.

- **Attachment 6: Impact Statement (one-page limit): Upload as “Impact.pdf”. The Impact Statement should be written in plain language for lay persons.** Describe how the proposed research demonstrates the potential to have a major impact on patient outcomes. Identify the patient outcomes that will be most affected. Articulate how the proposed study will apply a convergent methodology, e.g., where a physical science approach lends support and enhancement to our understanding of melanoma initiation and progression. Explain how the research responds to gaps in technology and/or technological development and advancement in the melanoma field with a clear target to impact research and/or patient outcomes. Show how the research will, if successful, accelerate the movement of promising ideas into clinical applications and advance the evaluation and understanding of melanoma diagnostics, high risk markers, dormancy, and progression to metastasis.
- **Attachment 7: Cross-Disciplinary Personnel and Collaboration (three-page limit): Upload as “XDiscipline.pdf”.**

 - Describe the roles, responsibilities, and intellectual contribution of each partner in the proposed research. Describe how the project depends on the unique skills of each partner. Provide the time commitment for each partner.
 - Articulate how the cross-disciplinary approach (a physical science and a biomedical science) will advance the research beyond what can be accomplished with a singular disciplinary approach. Describe how the proposed collaboration involves a substantial contribution by each partner and the reciprocal flow of ideas and information.
 - Include a figure designating expertise, task responsibility, and convergence of the scientific approach. Include levels of effort by each PI.
 - If applicable, describe the role and responsibility of the military or VA investigator or early career investigator in the overall research project.

- **Attachment 8: Research Outcomes Plan: (one-page limit): Upload as “Outcomes.pdf”.** Describe the anticipated research outcomes (e.g., computational approaches, bioinformatics, devices, knowledge products, clinical products for development). Describe the methods and strategies proposed to move the anticipated research outcomes to the next phase of development or clinical application after successful completion of the project. Detail the funding strategy to transition to the next level of investigation, development, and/or commercialization (e.g., partners, internal/external funding opportunities to be applied for).
- **Attachment 9: Representations, if applicable (extramural submissions only): Upload as “RequiredReps.pdf”.** All extramural applicants must complete and submit the Required Representations template available on eBRAP (<https://ebrap.org/eBRAP/public/Program.htm>). For more information, see the General Application Instructions, Appendix 5, Section B, Representations.
- **Attachment 10: Suggested Collaborating DoD Military Facility Budget Format, if applicable: Upload as “MFBudget.pdf”.** If a military facility (Military Health System facility, research laboratory, medical treatment facility, dental treatment facility, or a DoD activity embedded with a civilian medical center) will be a collaborator in performance of the project, complete a separate budget, using “Suggested Collaborating DoD Military Facility Budget Format,” available for download on the eBRAP “Funding Opportunities & Forms” web page <https://ebrap.org/eBRAP/public/Program.htm>, including a budget justification, for each military facility as instructed. - Key Personnel Biographical Sketches (five-page limit each): Upload as “Biosketch_LastName.pdf”.
- Key Personnel Previous/Current/Pending Support (no page limit): Upload as “Support_LastName.pdf”.

Collaborating organizations should budget associated indirect costs in accordance with each organization’s negotiated rate. The combined budgeted direct

costs approved by the Government will not exceed **\$700,000** or use an indirect cost rate exceeding each organization's negotiated rate.

A separate award will be made to each PI's organization.

The PIs are expected to be partners in the research, and direct cost funding should be divided accordingly, unless otherwise warranted and clearly justified.

Direct costs may also include:

- Travel in support of multidisciplinary collaborations.
- Costs for two investigators to travel to one scientific/technical meeting per year. The intent of travel costs to scientific/technical meeting(s) is to present project information or disseminate project results from the MRP Technology Development Partnership Award.

Direct costs must not be requested for:

- Clinical trial costs

For extramural awards with an intragovernmental component, direct transfer of funds from an extramural award recipient to a DoD or other Federal agency is not allowed except under very limited circumstances. Funding to intramural DoD and other Federal agencies will be managed through a direct funds transfer. Intramural applicants are responsible for coordinating through their agency's procedures the use of contractual or assistance funding awards or other appropriate agreements to support extramural collaborators.

- Whether the hypothesis to be tested or the objective to be reached responds to an important question related the FY20 MRP Focus Area: Bioengineering (e.g., computational, imaging) approaches to address diagnostics, high risk markers, dormancy, and metastasis.
- Whether the research addresses the FY20 MRP Challenge Statement.
- How well the application supports the rationale to test the hypothesis and reach the final objective.
- Whether the included preliminary data supports the objectives of the research proposed.
- How well the technological study design demonstrates the requirement analysis, architecture design, technical/derived technical requirements, verification and validation analysis, methodology, and technical planning, etc.
- To what extent the application describes the statistical evaluation and validation of the technology, especially the specificity and selectivity.
- To what extent the application articulates potential problems and potential pitfalls, and addresses alternative approaches that are logical and reasonable to support the hypothesis.
- Whether the application demonstrates the availability of tissue, data, or human subjects, if applicable.
- If applicable, how well the application describes all animal studies, and whether the animal model recapitulates melanoma.
- Whether the studies are designed to achieve the objectives, including endpoints/outcome measures to be used.
- **Impact**
 - Whether the application demonstrates how the proposed research will have the potential to have a major impact on patient outcomes.
 - Whether the applications identifies what the patient outcomes that will be most affected are.
 - To what extent the application articulates how the proposed study will apply a convergent methodology, e.g., where a physical science approach lends support and enhancement to our understanding of melanoma initiation and progression.
 - How well the application explains how the research responds to gaps in technology and/or technological development and advancement in the melanoma field with a clear target to impact research and/or patient outcomes.

- Whether the application demonstrates how the research, if successful, will accelerate the movement of promising ideas into clinical applications and advance the evaluation and understanding of melanoma diagnostics, high risk markers, dormancy, and progression to metastasis.
- **Cross-Disciplinary Personnel and Collaboration**
 - Based on information in the biographical sketches, to what degree each PI has the research experience to function as a partner in the proposed collaborative project.
 - To what extent the plans for communication, decision-making, allocation of resources, coordination of research progress and results, and sharing of data among all PIs and organizations participating in the project support the advancement of the research. Whether a plan for management of intellectual property is in place.
 - Whether the roles, responsibilities, and intellectual contribution of each partner in the proposed research depends on the unique skills of each partner, including the time commitment for each partner.
 - To what degree the cross-disciplinary approach (a physical science and a biomedical science) will advance the research beyond the expectations of a singular disciplinary approach.
 - Whether the proposed collaboration involves a substantial contribution by each partner and the reciprocal flow of ideas and information.
 - How well the application described the role and responsibility of the military or VA investigator or early career investigator in the overall research project (if applicable).
 - Whether the figure clearly defines the expertise, task responsibility, level of effort of each PI, and convergence of the scientific approach.
- **Research Outcome Plan:**
 - Whether the application described the anticipated research outcomes, including knowledge products, clinical products for development, etc.
 - How well the application demonstrated methods and strategies to move the anticipated research outcomes to the next phase of development or clinical application after successful completion of the project.
 - Whether the application detailed the funding strategy to transition to the next level of investigation, development, and/or commercialization (e.g., partners, internal/external funding opportunities to be applied for).

In addition, the following **unscored** criteria will also contribute to the overall evaluation of the application:

- **Budget**
 - Whether the **direct** costs exceed the allowable direct costs as published in the Program Announcement.
 - Whether the budget is appropriate for the proposed research.
- **Environment**
 - To what degree the scientific environment is appropriate for the proposed research.
 - To what degree the research requirements are supported by the availability of and accessibility to facilities and resources (including collaborative arrangements).
 - To what degree the quality and extent of institutional support are appropriate.
- **Application Presentation**
 - To what extent the writing, clarity, and presentation of the application components influence the review.

II.E.1.b. Programmatic Review

To make funding recommendations and select the application(s) that, individually or collectively, will best achieve the program objectives, the following criteria are used by programmatic reviewers:

- Ratings and evaluations of the peer reviewers
- Relevance to the mission of the DHP and FY20 MRP, as evidenced by the following:
 - Adherence to the intent of the award mechanism
 - Program portfolio balance and composition
 - Adherence to the FY20 MRP Challenge Statement
 - Relevance to the FY20 MRP Focus Area: bioengineering approaches to address diagnostics, high risk markers, dormancy, and metastasis.
 - Relative impact

II.E.2. Application Review and Selection Process

All applications are evaluated by scientists, clinicians, and consumers in a two-tier review process. The first tier is **peer review**, the evaluation of applications against established criteria to determine technical merit, where each application is assessed for its own merit, independent of other applications. The second tier is **programmatic review**, a comparison-based process in which applications with high scientific and technical merit are further evaluated for

programmatic relevance. Final recommendations for funding are made to the Commanding General, USAMRDC, on behalf of the DHA and the OASD(HA). ***The highest-scoring applications from the first tier of review are not automatically recommended for funding. Funding recommendations depend on various factors as described in [Section II.E.1.b, Programmatic Review](#).*** Additional information about the two-tier process used by the CDMRP can be found at <https://cdmrp.army.mil/about/2tierRevProcess>. An information paper describing the funding recommendations and review process for the award mechanisms for the MRP will be provided to the PI and posted on the CDMRP website.

All CDMRP review processes are conducted confidentially to maintain the integrity of the merit-based selection process. Panel members sign a statement declaring that application and evaluation information will not be disclosed outside the panel. Violations of confidentiality can result in the dissolving of a panel(s) and other corrective actions. In addition, personnel at the applicant or collaborating organizations are prohibited from contacting persons involved in the review and approval process to gain protected evaluation information or to influence the evaluation process. Violations of these prohibitions will result in the administrative withdrawal of the organization's application. Violations by panel members or applicants that compromise the confidentiality of the review and approval process may also result in suspension or debarment from Federal awards. Furthermore, the unauthorized disclosure of confidential information of one party to another third party is a crime in accordance with 18 USC 1905.

II.E.3. Integrity and Performance Information

Prior to making an assistance agreement award where the Federal share is expected to exceed the simplified acquisition threshold, as defined in 2 CFR 200.88, over the period of performance, the Federal awarding agency is required to review and consider any information about the applicant that is available in the Federal Awardee Performance and Integrity Information System (FAPIIS).
