II. DETAILED INFORMATION ABOUT THE FUNDING OPPORTUNITY

II.A. Program Description

Applications to the Fiscal Year 2020 (FY20) Neurotoxin Exposure Treatment Parkinson's (NETP) Program are being solicited by the U.S. Army Medical Research Acquisition Activity (USAMRAA) using delegated authority provided by United States Code, Title 10, Section 2358 (10 USC 2358). The execution management agent for this Program Announcement is the Congressionally Directed Medical Research Programs (CDMRP). The NETP Program was initiated in Fiscal Year 1997 (FY97) to provide support for research of exceptional scientific merit leading to an understanding of the cause, prevention, and treatment of Parkinson's disease (PD) in the context of neurotoxin exposure. Appropriations for the NETP Program from FY97 through FY19 totaled \$452.75 million (M). The FY20 appropriation is \$16M.

The vision of the NETP Program is to eliminate Parkinson's disease through neurotoxin exposure and treatment-related research in partnership with scientists and consumers.

The NETP Program invests in scientific research to better understand and treat the neuro-degenerative effects of PD associated with military deployment and environmental and/or occupational exposures. Research into military service-related risk factors is critical for past, present, and future Service members who may be affected by PD.

II.A.1. FY20 NETP Focus Areas

All applications to the FY20 NETP Program Early Investigator Research Award (EIRA) Program Announcement MUST address at least one of the following FY20 NETP Focus Areas:

- Quantifiable gene - environment interactions and the risk for or progression of Parkinson's disease following neurotoxin exposure. Though not limited to this list, the following are some examples of areas that are encouraged:
 - Genomewide genotyping/sequencing of existing cohorts (must include data sharing plan)
 - Environmental factors (toxins, medications, dietary, caffeine, among others)
 - Unbiased screens with biological validation
- Basic biology of non-motor symptoms that could lead to the development of new treatments for Parkinson's disease following neurotoxin exposure. Though not limited to this list, the following are some examples of areas that are encouraged:
 - Sleep
 - Cognition (relevant to Parkinson's disease)

- Psychiatric dysfunction
- Autonomic dysregulation
- System-level mechanism of dopamine refractory motor symptoms in Parkinson’s disease, including postural instability, freezing of gait, and treatment-associated dystonia, that could lead to development of new treatments in patients with neurotoxin exposure. Though not limited to this list, the following are some examples of approaches that could be used:
 - Circuitry
 - Pathophysiology
 - Neurochemistry
- Clinical and research application of digital health technology leading to development of new treatments for Parkinson’s disease in those individuals exposed to neurotoxins.
 - Early identification
 - Innovative data analytic methods
 - Disease subtyping

II.A.2. Award History

The NETP Program Early Investigator Research Award mechanism was first offered in FY17. Since then, 43 EIRA applications have been received, and 14 have been recommended for funding.

II.B. Award Information

The NETP Program EIRA supports neurotoxin exposure and treatment-related Parkinson’s disease research opportunities for investigators in the early stages of their careers, under the guidance of a designated Mentor(s). The Early Investigator is considered the Principal Investigator (PI) of the application and must exhibit strong potential for, and commitment to, pursuing a career as an investigator at the forefront of Parkinson’s disease research; however, the PI is not required to have previous Parkinson’s disease research experience. Applications must include at least one Mentor, appropriate to the proposed research project, who has experience in Parkinson’s disease research and mentoring as demonstrated by a record of active funding, recent publications, and successful mentorship. The selected Mentor(s) should also demonstrate a clear commitment to the development of the PI toward independence as a neurotoxin exposure and treatment-related Parkinson’s disease researcher.

The following are important aspects of the EIRA:

- *All applications for the EIRA are to be written by the PI, with appropriate direction from the Mentor(s).*

- **Principal Investigator:** The EIRA supports early-career investigators exploring innovative, high-impact ideas or new technologies applicable to neurotoxin exposure and treatment-related Parkinson's disease research and/or patient care. The NETP Program seeks applications from investigators working in a broad spectrum of disciplines including, but not limited to, basic science, engineering, bioinformatics, population science, translational research, and clinical research. The application should demonstrate the PI's potential for, and commitment to, pursuing a career in neurotoxin exposure and treatment-related Parkinson's disease research under the guidance of a designated Mentor(s). Evaluated criteria will include mentorship and the mentorship environment with an identified path to independence.
- **Researcher Development Plan:** The application must outline an individualized Researcher Development Plan. The Researcher Development Plan should include a clearly articulated strategy for acquiring the necessary skills, competence, and expertise that will enable the PI to successfully complete the proposed research project and foster the PI's development as an independent researcher in neurotoxin exposure and treatment-related Parkinson's disease research. An environment appropriate to the proposed mentoring and research at the PI's institution must be clearly described. Additional necessary resources and/or mentorship may be provided through collaboration(s) with other institutions. If the PI will be utilizing resources at another institution to successfully complete the proposed project, then the PI is strongly encouraged to designate a co-Mentor at the collaborating institution.
- **Focus Area:** The proposed research *must* address at least one of the four [FY20 NETP Focus Areas](#) stated.
- **Research Strategy and Feasibility:** Experimental strategies may be novel or may be based on strong rationale derived from previously published data, presented preliminary data, or literature review. The feasibility of the research design and methods should be well-defined, and a clear plan should be articulated as to how the proposed goals of the project can be achieved.

Preliminary data are not required. Any unpublished, preliminary data provided should originate from the PI, Mentor(s), or member(s) of the collaborating team. The preliminary data must support the feasibility of the study.

- **Impact:** The proposed research, if successful, should impact an area of paramount importance in Parkinson's disease, in the context of neurotoxin exposure and treatment-related Parkinson's research. In the context that neurotoxin exposure increases the risk for Parkinson's disease, the application must propose neurotoxin exposure and treatment-related Parkinson's disease research. The application must clearly and explicitly describe the potential impact of the proposed study on neurotoxin exposure-related Parkinson's disease and convey its level of significance. The research should benefit individuals with Parkinson's disease, by improving the understanding, prevention, diagnosis, and/or treatment of neurotoxin exposure-related Parkinson's disease. The application must clearly describe the short-term impact as well as the long-term impact, in the understanding, prevention, diagnosis, and/or treatment of Parkinson's disease caused by risk factors such as military deployment and environmental and/or occupational exposures.

The proposed research must be relevant to active duty Service members, Veterans, military beneficiaries, and/or the American public.

The types of awards made under the Program Announcement will be assistance agreements. An assistance agreement is appropriate when the Federal Government transfers a “thing of value” to a “state, local government,” or “other recipient” to carry out a public purpose of support or stimulation authorized by a law of the United States instead of acquiring property or service for the direct benefit and use of the U.S. Government. An assistance agreement can take the form of a grant or cooperative agreement. The level of involvement on the part of the Department of Defense (DoD) during project performance is the key factor in determining whether to award a grant or cooperative agreement. If “no substantial involvement” on the part of the funding agency is anticipated, a grant award will be made (31 USC 6304). Conversely, if substantial involvement on the part of the funding agency is anticipated, a cooperative agreement will be made (31 USC 6305), and the award will identify the specific substantial involvement. Substantial involvement may include, but is not limited to, collaboration, participation, or intervention in the research to be performed under the award. The award type, along with the start date, will be determined during the negotiation process.

The anticipated total costs budgeted for the entire period of performance for an FY20 NETP Program EIRA will not exceed **\$400,000**. Refer to [Section II.D.5, Funding Restrictions](#), for detailed funding information.

Awards will be made no later than September 30, 2021. For additional information refer to [Section II.F.1, Federal Award Notices](#).

The CDMRP expects to allot approximately \$1.6M to fund approximately four Early Investigator Research Award applications. Funding of applications received is contingent upon the availability of Federal funds for this program as well as the number of applications received, the quality and merit of the applications as evaluated by scientific and programmatic review, and the requirements of the Government. Funds to be obligated on any award resulting from this funding opportunity will be available for use for a limited time period based on the fiscal year of the funds. It is anticipated that awards made from this FY20 funding opportunity will be funded with FY20 funds, which will expire for use on September 30, 2026.

Research involving human subjects and human anatomical substances is permitted; however, clinical trials are not allowed under this Program Announcement.

Research Involving Human Anatomical Substances, Human Subjects, or Human Cadavers: All DoD-funded research involving new and ongoing research with human anatomical substances, human subjects, or human cadavers must be reviewed and approved by the U.S. Army Medical Research and Development Command (USAMRDC) Office of Research Protections (ORP), Human Research Protection Office (HRPO), prior to research implementation. This administrative review requirement is in addition to the local Institutional Review Board (IRB) or Ethics Committee (EC) review. Local IRB/EC approval at the time of submission is *not* required. ***Allow a minimum of 2 to 3 months for HRPO regulatory review and approval processes.*** Refer to the General Application Instructions, Appendix 1, and the

Human Subject Resource Document available on the electronic Biomedical Research Application Portal (eBRAP) “Funding Opportunities & Forms” web page (<https://ebrap.org/eBRAP/public/Program.htm>) for additional information. If the proposed research is cooperative (i.e., involving more than one institution), a written plan for single IRB review arrangements must be provided at the time of application submission or award negotiation. The lead institution responsible for developing the master protocol and master consent form should be identified and should be the single point of contact for regulatory submissions and requirements.

A clinical trial is defined as a research study in which one or more human subjects are prospectively assigned to one or more interventions (which may include placebo or other control) to evaluate the effects of the interventions on biomedical or behavioral health-related outcomes.

Use of DoD or Department of Veterans Affairs (VA) Resources: If the proposed research involves access to active duty military patient populations and/or DoD resources or databases, the application must describe the access at the time of submission and include a plan for maintaining access as needed throughout the proposed research. Refer to [Section II.D.2.b.ii, Full Application Submission Components](#), for detailed information. Refer to the General Application Instructions, Appendix 1, for additional information.

Research Involving Animals: All DoD-funded research involving new and ongoing research with animals must be reviewed and approved by the USAMRDC ORP Animal Care and Use Review Office (ACURO), in addition to the local Institutional Animal Care and Use Committee (IACUC) of record. IACUC approval at the time of submission is *not* required. ***Allow at least 3 to 4 months for ACURO regulatory review and approval processes for animal studies.*** Refer to the General Application Instructions, Appendix 1, for additional information.

II.C. Eligibility Information

II.C.1. Eligible Applicants

II.C.1.a. Organization: All organizations, including international organizations, are eligible to apply.

Government Agencies Within the United States: Local, state, and Federal Government agencies are eligible to the extent that applications do not overlap with their fully funded internal programs. Such agencies are required to explain how their applications do not overlap with their internal programs.

As applications for this Program Announcement may be submitted by extramural and intramural organizations, these terms are defined below.

Extramural Organization: An eligible non-DoD organization. Examples of extramural organizations include academic institutions, biotechnology companies, foundations, Federal Government organization other than the DoD, and research institutes.

Intramural DoD Organization: A DoD laboratory, DoD military treatment facility, and/or DoD activity embedded within a civilian medical center. ***Intramural Submission: Application submitted by a DoD organization for an intramural investigator working within a DoD laboratory or military treatment facility or in a DoD activity embedded within a civilian medical center.***

USAMRAA makes awards to eligible organizations, not to individuals.

II.C.1.b. Principal Investigator

To be named as the PI on the application, the investigator must be a postdoctoral or clinical fellow, instructor, or assistant professor within 10 years of advanced degree training or residency training completion.

Each investigator may be named on only one NETP Program EIRA application as PI.

An eligible PI, regardless of ethnicity, nationality, or citizenship status, must be employed by, or affiliated with, an eligible organization.

The CDMRP encourages all PIs to participate in a digital identifier initiative through Open Researcher and Contributor ID, Inc. (ORCID). Registration for a unique ORCID identifier can be done online at <https://orcid.org/>.

II.C.2. Cost Sharing

Cost sharing/matching is not an eligibility requirement.

II.C.3. Other

Organizations must be able to access **.gov** and **.mil** websites in order to fulfill the financial and technical deliverable requirements of the award and submit invoices for payment.

For general information on required qualifications for award recipients, refer to the General Application Instructions, Appendix 3.

Refer to [Section II.H.2, Administrative Actions](#), for a list of administrative actions that may be taken if a pre-application or application does not meet the administrative, eligibility, or ethical requirements defined in this Program Announcement.

II.D. Application and Submission Information

Submission of applications that are essentially identical or propose essentially the same research project to different funding opportunities within the same program and fiscal year is prohibited and will result in administrative withdrawal of the duplicative application(s).

Extramural Submission:

- Pre-application content and forms must be accessed and submitted at eBRAP.org.
- Full application packages must be accessed and submitted at Grants.gov.

Intramural DoD Submission:

- Pre-application content and forms must be accessed and submitted at eBRAP.org.
- Full application packages must be accessed and submitted at eBRAP.org

Note: Applications from an intramural DoD organization or from an extramural Federal Government organization may be submitted to Grants.gov through a research foundation.

II.D.1. Address to Request Application Package

eBRAP is a multifunctional web-based system that allows PIs to submit their pre-applications electronically through a secure connection, to view and edit the content of their pre-applications and full applications, to receive communications from the CDMRP, and to submit documentation during award negotiations and period of performance.

Contact information for the CDMRP Help Desk and the Grants.gov Contact Center can be found in [Section II.G, Federal Awarding Agency Contacts](#).

II.D.2. Content and Form of the Application Submission

Submission is a two-step process requiring both ***pre-application*** (eBRAP.org) and ***full application*** (eBRAP.org or Grants.gov) as indicated below. The submission process should be started early to avoid missing deadlines. There are no grace periods. Full application submission guidelines differ for extramural (Grants.gov) and intramural (eBRAP.org) organizations (refer to [Table 1. Full Application Guidelines](#)).

The application title, eBRAP log number, and all information for the PI, Business Official(s), performing organization, and contracting organization must be consistent throughout the entire pre-application and full application submission process. Inconsistencies may delay application processing and limit or negate the ability to view, modify, and verify the application in eBRAP. If any changes need to be made, the applicant should contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507 prior to the application submission deadline.

II.D.2.a. Step 1: Pre-Application Submission Content

During the pre-application process, eBRAP assigns each submission a unique log number. This unique eBRAP log number is required during the full application submission process.

To begin the pre-application process, first select whether the submitting organization is extramural or intramural, then confirm your selection or cancel. **Incorrect selection of extramural or intramural submission type will delay processing.**

If an error has been made in the selection of extramural versus intramural and the pre-application submission deadline has passed, the PI or Business Official must contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507 to request a change in designation.

All pre-application components must be submitted by the PI through eBRAP (<https://eBRAP.org>).

The applicant organization and associated PI and mentor(s) identified in the pre-application should be the same as those intended for the subsequent application submission. If any changes are necessary after submission of the pre-application, the applicant must contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507.

PIs with an ORCID identifier should enter that information in the appropriate field in the “My Profile” tab in the “Account Information” section of eBRAP.

The pre-application consists of the following components, which are organized in eBRAP by separate tabs (refer to the General Application Instructions, Section II.B, for additional information on pre-application submission):

- **Tab 1 – Application Information**

Submission of application information includes assignment of primary and secondary research classification codes, which may be found at <https://ebrap.org/eBRAP/public/Program.htm>. Applicants are strongly encouraged to review and confirm the codes prior to making their selection.

- **Tab 2 – Application Contacts**

Enter contact information for the PI. Enter the organization’s Business Official responsible for sponsored program administration (the “person to be contacted on matters involving this application” in Block 5 of the Grants.gov SF424 Research & Related Form). The Business Official must be either selected from the eBRAP list or invited in order for the pre-application to be submitted.

Select the performing organization (site at which the PI will perform the proposed work) and the contracting organization (organization submitting on behalf of the PI, which corresponds to Block 5 on the Grants.gov SF424 Research & Related Form), and click on “Add Organizations to this Pre-application.” The organization(s) must be either selected from the eBRAP drop-down list or invited in order for the pre-application to be submitted.

It is recommended that applicants identify an Alternate Submitter in the event that assistance with pre-application submission is needed.

- **Tab 3 – Collaborators and Key Personnel**

Enter the name, organization, and role of all collaborators and key personnel associated with the application.

[FY20 NETP Programmatic Panel members](#) should not be involved in any pre-application or application. For questions related to panel members and pre-applications or applications, refer to [Section II.H.2.c, Withdrawal](#), or contact the CDMRP Help Desk at help@eBRAP.org or 301-682-5507.

- **Tab 4 – Conflicts of Interest**

List all individuals other than collaborators and key personnel who may have a conflict of interest in the review of the application (including those with whom the PI has a personal or professional relationship).

- **Tab 5 – Pre-Application Files**

Letter of Intent (LOI) (one-page limit): Provide a brief description of the research to be conducted. Include the [FY20 NETP Focus Area](#) under which the application will be submitted. LOIs are used for program planning purposes only (e.g., reviewer recruitment) and will not be reviewed during either the peer or programmatic review sessions.

- **List of Individuals Providing Confidential Letters of Recommendation:** Enter contact information for a minimum of two and a maximum of three individuals who will provide letters of recommendation. Each individual will receive an email generated from eBRAP containing specific instructions on how to upload their letter.

- **Tab 6 – Submit Pre-Application**

This tab must be completed for the pre-application to be accepted and processed.

II.D.2.b. Step 2: Full Application Submission Content

Applications will not be accepted unless notification of invitation has been received.

The CDMRP cannot make allowances/exceptions to its policies for submission problems encountered by the applicant organization using system-to-system interfaces with Grants.gov.

Each application submission must include the completed full application package for this Program Announcement. The full application package is submitted by the Authorized Organizational Representative through Grants.gov (<https://www.grants.gov/>) for extramural organizations or through eBRAP (<https://ebrap.org/>) for intramural organizations. See Table 1 below for more specific guidelines.

II.D.2.b.i. Full Application Guidelines

Extramural organizations must submit full applications through Grants.gov. Applicants must create a Grants.gov Workspace for submission, which allows the application components to be completed online and routed through the applicant organization for review prior to submission. Applicants may choose to download and save individual PDF forms rather than filling out webforms in Workspace. A compatible version of Adobe Reader **must** be used to view, complete, and submit an application package consisting of PDF forms. If more than one person

is entering text into an application package, the *same version* of Adobe Reader software should be used by each person. Check the version number of the Adobe software on each user’s computer to make sure the versions match. Using different versions of Adobe Reader may cause submission and/or save errors – even if each version is individually compatible with Grants.gov. Refer to the General Application Instructions, Section III, and the “Apply For Grants” page of Grants.gov (<https://www.grants.gov/web/grants/applicants/apply-for-grants.html>) for further information about the Grants.gov Workspace submission process. Submissions of extramural applications through eBRAP may be withdrawn.

Do not password protect any files of the application package, including the Project Narrative.

Inclusion of URLs that provide additional information to expand the Project Narrative and could confer an unfair competitive advantage is prohibited and may result in administrative withdrawal of the application.

Describe the proposed project in detail using the outline below. *The Project Narrative must be written by the PI while also showing evidence of appropriate direction from the Mentor(s).*

- **Principal Investigator:** The PI should describe how their achievements (as reflected by academic performance, awards, honors, and/or previous publications and funding) indicate the potential for a successful career as a Parkinson’s disease researcher in the context of neurotoxin exposure and treatment-related Parkinson’s disease research. The PI should describe how their stated career goals demonstrate a strong personal commitment to pursuing an independent career as a leader in neurotoxin exposure and treatment-related Parkinson’s disease research. The PI should describe how their proposed level of effort, if not 100%, is appropriate for successful completion of the proposed work.
- **Mentor(s):** Describe the background, funding, publications, and experience of the Mentor(s) in Parkinson’s disease research. Explain how they will assist the PI throughout the period of performance in developing toward independence in neurotoxin exposure and treatment-related Parkinson’s disease research. Describe their track record in mentoring early-career investigators in Parkinson’s disease research.

 - Study Design: Briefly describe the study design to include methodology, statistical analysis, and appropriate controls.
 - Focus Area: State how the study will address at least one of the [FY20 NETP Focus Areas](#).
- **Personnel**
- Describe the PI’s career goals and potential for a career at the forefront of neurotoxin exposure and treatment-related Parkinson’s disease research.
 - Describe how the proposed research project will prepare the PI to make valuable contributions to the understanding and treatment of Parkinson’s disease.
- **Impact:** Summarize the impact of the proposed research, if successful, on the understanding, prevention, diagnosis, and/or treatment of Parkinson’s disease in the context of neurotoxin exposure.
- **Attachment 4: Lay Abstract (one-page limit): Upload as “LayAbs.pdf”.** The lay abstract is used by all reviewers. Abstracts of all funded research projects will be posted publicly. **Do not include proprietary or confidential information.** Use only characters available on a standard QWERTY keyboard. Spell out all Greek letters, other non-English letters, and symbols. Graphics are not allowed.

Lay abstracts should be written using the outline below. **Do not duplicate the technical abstract.** Minimize use of acronyms and abbreviations, where appropriate. The lay abstract is an important component of the application review process because it addresses issues of particular interest to the consumer community.

- Clearly describe the objectives and rationale for the proposed study and intervention in a manner readily understood by readers without a background in science or medicine.
- Describe the ultimate applicability and impact of the research.
 - What types of patients will it help, and how will it help them?
 - What are the potential clinical applications, benefits, and risks?
 - What is the projected time it may take to achieve a patient-related outcome?
 - In the context of neurotoxin exposure, what is the likely impact of this study on the understanding, prevention, diagnosis, and/or treatment of Parkinson’s disease?

- Describe the PI’s career goals in neurotoxin exposure and treatment-related Parkinson’s disease research.
 - How does the research plan support the PI in achieving these goals?
 - How does the mentorship and [Researcher Development Plan](#) support the PI in achieving these goals?
- **Attachment 5: Statement of Work (three-page limit): Upload as “SOW.pdf”.** The suggested SOW format and examples specific to different types of research projects are available on the eBRAP “Funding Opportunities & Forms” web page (<https://ebrap.org/eBRAP/public/Program.htm>). For the Early Investigator Research Award mechanism, use the SOW format example titled, “SOW (Statement of Work) Generic Format.” The SOW must be in PDF format prior to attaching.

The short-term impact will be anticipated outcome(s)/product(s) from the proposed research. The long-term impact may be beyond the scope of the proposed research. Describe how the proposed research addresses the [FY20 NETP Focus Areas](#).
- **Attachment 8: Letter of Eligibility (one-page limit): Upload as “Eligibility.pdf”.** Provide a letter signed by the PI and the Department Chair, Dean, or equivalent official to verify that the eligibility requirements have been met. The letter should verify that the PI is no more than 10 years from their advanced degree training or residency training completion (or equivalent) as of the application deadline (Refer to [Section II.C, Eligibility Information](#)).
- **Attachment 9: Representations, if applicable (extramural submissions only): Upload as “RequiredReps.pdf”.** All extramural applicants must complete and submit the Required Representations template available on eBRAP (<https://ebrap.org/eBRAP/public/Program.htm>). - Key Personnel Previous/Current/Pending Support (no page limit): Upload as “Support_LastName.pdf”.
 - Include mentor’s (and co-mentor’s, if applicable) previous/current/pending support.

Research & Related Budget: For extramural submissions (via Grants.gov), refer to the General Application Instructions, Section III.A.5, and for intramural submissions (via eBRAP), refer to the General Application Instructions, Section IV.A.4, for detailed information.

Budget Justification (no page limit): Upload as “BudgetJustification.pdf”. The budget justification for the entire period of performance must be uploaded to the Research & Related Budget after completion of the budget for Period 1.

 - The PI’s potential for a highly productive career as a Parkinson’s disease researcher in the context of neurotoxin exposure;
 - The proposed interactions of the Mentor with the PI during the PI’s research project;

- The mentoring environment, including ongoing Parkinson’s disease research in the Mentor’s laboratory and in the organization as a whole, resources available, and how this environment will promote the development of the PI as a Parkinson’s disease researcher; and
- The degree to which the PI participated in the project development and application preparation, and the degree to which the PI will participate in the execution of the application if funded.
- ***Additional confidential letters of recommendation (one is required; maximum of two).*** Specifically, each letter should offer the writer’s perspective on:
 - The PI’s qualifications, characteristics, and achievements;
 - The PI’s potential for productivity and desire for establishing a successful and independent career in neurotoxin exposure and treatment-related Parkinson’s disease research;
 - The relevance of the proposed research project to developing the PI’s career in Parkinson’s disease research; and
 - The suitability of the Mentor(s) and the research environment for providing the PI with a solid foundation to support an independent career in Parkinson’s disease research.

II.D.3. Dun and Bradstreet Data Universal Numbering System (DUNS) Number and System for Award Management (SAM)

accordance with the organization's negotiated rate. No budget will be approved by the Government exceeding \$400,000 total costs or using an indirect cost rate exceeding the organization's negotiated rate.

All direct and indirect costs of any subaward or contract must be included in the total direct costs of the primary award.

The applicant may request the entire maximum funding amount for a project that may have a period of performance less than the maximum 2 years.

For this award mechanism, direct costs may be requested for (not all inclusive):

- Travel in support of multidisciplinary collaborations.
- Costs for one investigator to travel to one scientific/technical meeting per year to present project information or disseminate project results and/or attend workshops as designated [Researcher Development Plan](#).

Must not be requested for:

- Clinical trial costs
- Equipment
- Mentor salary

For extramural awards with an intragovernmental component, direct transfer of funds from an extramural award recipient to a DoD or other Federal agency is not allowed except under very limited circumstances. Funding to intramural DoD and other Federal agencies will be managed through a direct funds transfer. Intramural applicants are responsible for coordinating through their agency's procedures the use of contractual or assistance funding awards or other appropriate agreements to support extramural collaborators.

 - To what extent the PI's stated career goals demonstrate a strong personal commitment to pursuing an independent career as a leader in neurotoxin exposure and treatment-related Parkinson's disease research.
 - To what extent the letters of recommendation from the Mentor(s) and others support the PI's potential for a highly productive career as a neurotoxin exposure and treatment-related Parkinson's disease researcher.
 - Whether the PI's proposed level of effort, if not 100%, is appropriate for successful completion of the proposed work.
 - **Mentor(s)**
 - Whether there is at least one Mentor who is an established Parkinson's disease researcher, as evidenced by a demonstrated record of active funding and recent publications in Parkinson's disease research.
 - How the Mentor (and co-Mentor, if applicable) will assist the PI throughout the period of performance in developing toward independence in neurotoxin exposure and treatment-related Parkinson's disease research.
 - To what extent the Mentor's track record for training young investigators indicates the potential for successful mentoring of the PI in Parkinson's disease research.

- How well the individualized [Researcher Development Plan](#) will provide the PI with an opportunity to develop a research project, investigate a problem or question in neurotoxin exposure and treatment-related Parkinson's disease research, and effectively prepare him/her for a career as an independent Parkinson's disease researcher.
- To what extent the mentor(s) will support the researcher development plan.
- To what extent the scientific environment at the primary institution and collaborating institution(s) is appropriate for the proposed research and career development activities, including professional interaction with established Parkinson's disease researchers.
- To what degree the proposed research project and mentoring experience will bring the PI to the forefront of Parkinson's disease research.

- **Research Strategy and Feasibility**

- How well the scientific rationale supports the proposed research and its feasibility, as demonstrated by a critical review and analysis of the literature, Parkinson's disease- and neurotoxin exposure-relevant preliminary data (if included), and/or logical reasoning.
- How well the hypotheses or objectives, aims, experimental design, methods, and statistical analysis are developed.
- How well the study is designed to achieve reproducible and rigorous results, including controls, sample size estimation, blinding, randomization, power analysis, and data handling.
- How well any animal studies proposed are designed to achieve the objectives, including the choice of model and endpoints/outcome measures to be used (if applicable).
- To what extent the proposed research project is feasible as described.
- How well the application identifies potential problems and addresses alternative approaches.
- Whether the application has provided sufficient evidence to support availability of and access to the populations/samples required for the study, and whether the plan for acquiring the necessary research resources is sufficient for the proposed research project (if applicable).

- Whether experiments to address the clinical relevance of the anticipated findings have been incorporated into the study design (if applicable).

- **Impact**

- Whether the application has provided sufficient evidence to support the pathway to making a clinical impact for individuals with, or at risk for, Parkinson's disease, in the context of neurotoxin exposure.
- To what degree the proposed research, whether in the short-term or long-term, would make a major impact in the understanding, prevention, diagnosis, and/or treatment of Parkinson's disease caused by risk factors such as military deployment and environmental and/or occupational exposures.
- How well the proposed research addresses the [FY20 NETP Focus Areas](#).

In addition, the following unscored criteria will also contribute to the overall evaluation of the application:

- **Budget**

- Whether the total maximum costs are equal to or less than the allowable total maximum costs as published in the Program Announcement.
- Whether the budget is appropriate for the proposed research.

- **Environment**

- To what extent the research requirements are adequately supported by the availability and accessibility of facilities and resources (including collaborative arrangements and/or intellectual property plans as applicable).

- **Application Presentation**

- To what extent the writing, clarity, and presentation of the application components influence the review.

II.E.2. Application Review and Selection Process

All applications are evaluated by scientists, clinicians, and consumers in a two-tier review process. The first tier is **peer review**, the evaluation of applications against established criteria to determine technical merit, where each application is assessed for its own merit, independent of other applications. The second tier is **programmatic review**, a comparison-based process in which applications with high scientific and technical merit are further evaluated for programmatic relevance. Final recommendations for funding are made to the Commanding General, USAMRDC, on behalf of the DHA and the OASD(HA). ***The highest-scoring applications from the first tier of review are not automatically recommended for funding. Funding recommendations depend on various factors as described in [Section II.E.1.b, Programmatic Review](#).*** Additional information about the two-tier process used by the CDMRP can be found at <https://cdmrp.army.mil/about/2tierRevProcess>. An information paper describing the funding recommendations and review process for the award mechanisms for the NETP Program will be provided to the PI and posted on the CDMRP website.

All CDMRP review processes are conducted confidentially to maintain the integrity of the merit-based selection process. Panel members sign a statement declaring that application and evaluation information will not be disclosed outside the panel. Violations of confidentiality can result in the dissolving of a panel(s) and other corrective actions. In addition, personnel at the applicant or collaborating organizations are prohibited from contacting persons involved in the review and approval process to gain protected evaluation information or to influence the evaluation process. Violations of these prohibitions will result in the administrative withdrawal of the organization's application. Violations by panel members or applicants that compromise the confidentiality of the review and approval process may also result in suspension or debarment from Federal awards. Furthermore, the unauthorized disclosure of confidential information of one party to another third party is a crime in accordance with 18 USC 1905.

II.E.3. Integrity and Performance Information
